**Minutes:** Minutes for March 22, 2023, April 12, 2023 and April 26, 2023 for approval. The April 12, 2023 minutes are missing a page. Dan said that is probably his fault. Chuck wanted to clarify that he doesn't make motions and the minutes had him making motions. Dan replied it was straight from the recording. Dan will get the missing page for the April 12, 2023 minutes to bring to the next meeting. Steve said it may confuse the person doing them when Chuck says he "entertains the motion". **Reports:**

Monday December 25<sup>th</sup> the office will be closed for Christmas. Last night we had a really nice Christmas Party for all of the town employees and firemen. It was well attended and very festive. Everyone appreciated the Board putting this on for them. Dan thanks them.

Dan has been monitoring prices on gas and diesel. It has trended down and with the turmoil in the Middle East he is afraid it will go back up. He locked in the prices at \$2.82 per gallon of gas and \$3.24 for a gallon of diesel. It is a two year commitment. He is also looking at a group to lock in electricity as well. It has come down a lot from six months ago.

Sarah Brewer is present from Slice O' Country. She has been selling jams and pickles etc. at the Common from a trailer. She is asking the Board for a four day extension on the use of the Common during the Boothbay Lights Celebration. She wants to park her building in the parking spot she is in and leave it there, weather permitting until January 2nd so she doesn't have to lug her supplies.

Steve wanted to thank the Town Public Works Crew for repairing the Refuse District parking lot.
